Invitation to Bid for *Concreting of Pathway, Sitio Bibihan, Brgy. Managpi, Calapan City*

1. The *City Government of Calapan*, through the *Local Development Fund* intends to apply the sum of ***Nine hundred ninety nine thousand five hundred eight pesos & 72/100 (PhP 999,508.72)*** being the Approved Budget for the Contract (ABC) to payments under the contract for ***Concreting of Pathway, Sitio Bibihan, Brgy. Managpi, Calapan City***. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *City Government of Calapan*, through the *Local Development Fund* intends to apply the sum of ***Nine hundred ninety nine thousand five hundred eight pesos & 72/100 (PhP 999,508.72)*** being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The *City Government of Calapan* now invites bids for the above Procurement Project. Completion of the Works is required *thirty (30) days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Bids and Awards Committee – City Government of Calapan* and inspect the Bidding Documents at the address given below during 8:00 a.m. to 2:00 p.m..
5. A complete set of Bidding Documents may be acquired by interested bidders on ***September 26, 2022 – October 4, 2022, 8:00 a.m. to 5:00 p.m.*** from given address and website/s below {*Insert if necessary: and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP 1,000.00.* The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
6. Bids must be duly received by the BAC Secretariat through manual at the office address as indicated below on or before ***1:30 A.M., October 4, 2022***. Late bids shall not be accepted.
7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
8. Bid opening shall be on ***1:30 A.M., October 4, 2022*** at the Executive Conference Room, New City Hall, Brgy. Guinobatan, Calapan City. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.

9. The *City Government of Calapan* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
