### **INVITATION TO BID FOR *Purchase and Delivery of TaMang School Supplies para sa Chikitings***

1. The *City Government of Calapan*, through the *20% Local Development Fund* intends to apply the sum of *Four million six hundred thirty one thousand seven hundred thirty five pesos & 50/100 (P 4,631,735.50)* being the ABC to payments under the contract for the *Purchase and Delivery of TaMang School Supplies para sa Chikitings*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *City Government of Calapan*, through the *20% Local Development Fund* intends to apply the sum of *Four million six hundred thirty one thousand seven hundred thirty five pesos & 50/100 (P 4,631,735.50)* for the *Purchase and Delivery of TaMang School Supplies para sa Chikitings* being the ABC to payments under the contract for each lot/item. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The *City Government of Calapan*, now invites bids for the above Procurement Project. Delivery of the Goods is required by at least thirty (30) days delivery period. Bidders should have completed, within *the relevant period* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders)
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the “Government Procurement reform Act.”
  - a. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
4. Prospective Bidders may obtain further information from Bids and Awards Committee - *City Government of Calapan* and inspect the Bidding Documents at the address given below during 8:00 a.m. to 2:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **August 26, 2022 – September 16, 2022, 8:00 a.m. to 5:00 p.m.** from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of P5,000.00*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees.

6. The *City Government of Calapan* will hold a **Pre-Bid Conference on September 9, 2022 at 2:00 P.M.** at the Executive Conference Room, New City Hall, Brgy. Guinobatan, Calapan City which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **1:30 P.M., September 16, 2022**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **1:30 P.M, September 16, 2022** at the Executive Conference Room, New City Hall, Brgy. Guinobatan, Calapan City. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
10. The *City Government of Calapan* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
